THIS THIRD AMENDMENT TO THE DECLARATION OF COVENANTS AND RESTRICTIONS FOR GRAND ADDISON II (this "Third Amendment") is made this 2/s+ day of July, 2010, by the membership of Grand Addison II Homeowners Association, Inc. (the "Association").

WITNESSETH:

WHEREAS, Grand Homes, Inc., a Texas corporation, and Beltway-Les Lacs, Ltd., a Texas limited partnership (collectively, the "Declarants") prepared an instrument entitled "Declaration of Covenants and Restrictions for Grand Addison II" dated August 30, 1993 and recorded on August 31, 1993 at Volume 93169, Page 4610 et seq. of the Real Property Records of Dallas County, Texas (the "Declaration"); and

WHEREAS, the Declaration was amended by that certain "First Amendment to the Declaration of Covenants and Restrictions for Grand Addison II" dated December 20, 1993 and recorded on December 28, 1993 at Volume 93250, Page 2272 et seq. of the Real Property Records of Dallas County, Texas (the "First Amendment"); and

WHEREAS, the Declaration was supplemented by that certain "Supplementary Declaration of Covenants and Restrictions for Grand Addison II (adding Grand Addison III)" dated July 22, 1994 and recorded on July 27, 1994 at Volume 94143, Page 03610 et seq. of the Real Property Records of Dallas County, Texas (the "First Supplement"); and

WHEREAS, the Declaration was again amended by that certain "Second Amendment to the Declaration of Covenants and Restrictions for Grand Addison II" dated July 9, 1996 and recorded on July 26, 1996 at Volume 96146, Page 02603 et seq. of the Real Property Records of Dallas County, Texas (the "Second Amendment"); and

WHEREAS, Article IX, Section 9.3(c) of the Declaration provides that the Declaration may be amended by the affirmative vote of the Members entitled to cast fifty-one percent (51%) of the votes of the Members of the Association entitled to vote who are present at a meeting duly called for such purpose; and

WHEREAS, Members who were entitled to cast fifty-one percent (51%) of the votes of the Members of the Association who were entitled to vote and who were present at the annual meeting of the Association held on April 28, 2009 voted in favor of the following amendment to the Declaration.

NOW, THEREFORE, the Declaration is hereby amended as follows:

- 1. Article VII, Section 7.5 of the Declaration is amended by adding the following subsection (d):
 - (d) <u>Yard of the Month Signs</u>. "Yard of the Month" signs are acceptable on an Owner's Lot when installed by or at the direction of the Board of Directors.
- 2. Except as amended by the First Amendment, the Second Amendment and this Third Amendment, the Declaration shall remain in full force and effect.


